## Stay Safe When a Power Line Is Down

#### **Know What to Do When Hazards Strike**

Be aware of hazards presented by downed power lines. Your life or the life of someone else depends on it.

#### **Never Touch a Downed Power Line**

Never touch anything or anyone in contact with a power line. You could be shocked by contact with the line or a secondary object or person.

When a live wire touches the ground, electricity fans out through the ground, similar to when a pebble hits water. You could be shocked when in the area of a downed power line. The minimum safe distance from a downed power line is 35 feet.



- Consider all wires energized and dangerous. Even de-energized lines may become energized at any time.
- Stay at least 35 feet away from downed lines.
- **Electricity can travel through the ground, fences, hoses, and playscapes.** A live wire, either on the ground or in trees, can harm you, even if you don't directly touch the line.
- **Electricity can also travel through tree limbs.** Never remove tree limbs or other items touching or near a downed wire. Call **City Light & Power at 541-938-5531** to report the tree limb.
- Never use any object to move a downed wire.
- Rubber gloves and rubber-soled shoes will not protect you from electrocution.
   Do not try to rescue someone who makes contact with a downed power line.

You risk becoming a victim yourself. Call **9-1-1**.

Now is the time to close your foundation vents and replace the filter on your heating system.

Check/replace the weather stripping on your entry doors and caulk around your windows.

### SAFETY ALERT FROM CITY LIGHT & POWER:

If you use (or plan to use) a generator in your home or business during a power outage, City Light &

Power reminds you to **PLEASE:** 

Open the Main Breaker on your electrical panel before starting your generator! If you plug in a generator into your home with the Main Electric Breaker closed you will back feed power onto our powerlines making a dangerous situation for our linemen trying to restore power..

Please keep your generator outside and downwind of your house at least 20 feet to prevent harmful exhaust gases from entering your home. No, running a generator inside the garage is not a good idea.

Before refueling your generator, shut off the engine and let the engine cool off for at least 5 minutes.

Make sure the electrical cord connecting the generator to the house is rated to carry the electrical load.

Put these reminders where you can see and use them for future reference.



### CORRECT DRIVER ACTIONS AT STOP SIGNS

An aspect of traffic safety that seems to be greatly misunderstood or perhaps even overlooked by drivers is the correct response and action at stop signs.

This article cannot address every conceivable scenario, so let's concentrate on probably the most obvious: a stop sign where there is a clearly drawn line, or marked crosswalk present.

The ONLY legal and safe driver response to this situation is to stop the vehicle completely BEHIND either a clearly drawn line if present, or, BEHIND a marked crosswalk when present.

After doing this, and if visibility is not clear, then a driver has a legal right to safely pull forward until they can see whether or not it is safe to proceed.

Be reminded that if any part of a motor vehicle initially stops over a clearly marked stop line at a stop sign, or over a crosswalk, this is a citable offense. Only after a driver performs the stop described above can he or she then proceed over a line or crosswalk.

The above also applies at four way stops, but, the correct responses to those traffic situations require adherence to another set of the rules of the road for drivers, to be covered in a later article.
