CITY COUNCIL SPECIAL SESSION MINUTES

BUSINESS ITEM:

BID AWARD - SEWER TREATMENT PLANT PRIMARY DIGESTER RECOATING

When staff performed cleaning of the interior of the primary digester, it was discovered the epoxy coating was peeling and some areas had voids of coating. This was discovered in the air gap area between the top of the digester liquid contents and lid. Anderson Perry & Associates was contracted with to compile a bid packet for the project. The project was advertised and bids were opened on Thursday, August 21, 2025. There were five bids received. Anderson Perry's recommendation was to award the bid to the second lowest bidder, Columbia Industrial Coatings, LLC, as the lowest bidder did not provide a responsible bid due to not having any experience with the type of coating material required. This recommendation was also reviewed by the City Attorney David Blanc who concurred with the recommendation. City Manager Morris stated the company could start on the project approximately two weeks after awarded the bid with another three weeks of work with an estimated completion date as the end of October.

Mayor Odman asked how long the warranty was good for.

Manager Morris replied, three years.

Councilor Holden motioned to approve and issue the notice of intent to award Primary Sewer Digester Recoating, Contract 319 to the lowest determined responsible bidder per OAR 137-049-0390 to Columbia Industrial Coatings, LLC. of Richland, Washington as per unit prices as bid. Councilor Irving seconded the motion which passed unanimously.

Councilor Lyon motioned to approve and issue the notice of award Primary Sewer Digester Recoating, Contract 319 to the lowest determined responsible bidder per OAR 137-049-0390 to Columbia Industrial Coatings, LLC. of Richland, Washington as per unit prices as bid, upon the conclusion of the seven-day protest period, planned for September 2, 2025. Councilor Jensen seconded the motion which passed unanimously.
