The **City of Milton-Freewater, Oregon (Owner)** invites Bids for the completion of the **Primary Digester Recoating - City Contract No. 319** project, which includes cleaning, sandblasting, and otherwise preparing inadequate surfaces; priming; and painting the interior of the Owner's 26-foot diameter concrete primary digester and steel lid, together with all other Work required to complete the Project as specified herein. The Notice to Proceed is not expected to be provided until after September 1, 2025.

Sealed Bids for the described Project will be received by the City of Milton-Freewater, Attention: Krista Gannon, at 501 Lamb Street, Milton-Freewater, Oregon 97862, until **2:00 p.m.**, local time, **Thursday, August 21, 2025**, at which time the Bids received will be publicly opened and read.

The Contract is subject to the applicable provisions of ORS 279C.800 through ORS 279C.870, the Oregon Prevailing Wage Law.

Bid security shall be furnished in accordance with the Instructions to Bidders.

The Project has an expected duration of 60 days.
