### General Terms and Conditions:

Renting Party agrees to the following terms:

1. Reservation is not confirmed until payment in full is paid.
2. Payment will be refunded with minimum 24-hour cancellation. Allow two (2) weeks for refund to arrive.
3. If rental is cancelled less than 24 hours before rental, 50% of payment is forfeited.
4. If adverse weather requires pool closure during the reserved event time a pro-rated refund will be paid.
5. If adverse weather requires pool closure prior to scheduled event, a new date may be scheduled or a refund may be offered.
6. Renting Party understands that any additional patrons, not listed and paid for will need to be paid for if outside rate parameters. No patrons will be allowed in the pool area unless included in this fee.
7. Renting Party will provide at least one person to check admittance of group to ensure only group members are admitted to the facility.
8. The Renting Party is responsible for ensuring that all parents follow all YMCA lifeguard instructions and requests. The Y reserves the right to ask parents and children to vacate the pool if the lifeguard believes that parent or child behavior is not compliant with Y requirements for lifeguard access and support. Lifeguards may require children to complete a water competency test to ensure swimming ability and at the lifeguard's discretion a swimmer may be required to wear a lifejacket provided by the Y when using the pool. Lifeguards will

enforce this rule. Failure to comply means the child will not be permitted to swim. For every four children under the age of 7 there must be one Renting Party adult in the water at the same time.

9. The Renting Party will be responsible for any cleaning costs or damage to the building or equipment caused by any member of the Renting group. If the building or equipment is damaged during the Renting, the Renting Party will be charged for any repair or cleaning costs. Any failure or delay to take responsibility for damage or cleaning may result in further rental requests by the Renting Party being declined. The City assumes no responsibility for personal property brought into the building or pool and for any lost personal property.
10. Cameras and photo devices are not permitted in restrooms.
11. Minors must be accompanied at all times by a Renting Party supervising adult.
